What is the Additional Services Fee?

The Additional Services Fee (ASF) covers everything that is not paid for by Government funding, which only covers the cost of childcare. The ASF includes: home-cooked meals prepared by our own on-site chef, any unfunded hours, music, dance, art, cookery, drama, yoga and RugbyTots classes. It also covers most trips, nappies, wipes, snacks, formula milk etc.

The ASF is made up of two elements - the first part covers all additional services (as listed above). The second part covers extra hours. E.g., on a full day a maximum of 6 funded hours can be accessed. In this case the ASF will cover the additional four hours of childcare.

How Many Hours of Funding?

3 & 4-year-olds (and eligible 2 year olds) receive 570 hours of funding each year (15 hours a week during term-time/38 weeks of the year). Hove Village is open 51 weeks of the year, so we allocate up to 11.25 hours per week over this period. Eligible 3 & 4-year-olds are entitled to up to 1140 funded hours per year, which is allocated as 22.5 hours each week for 51 weeks. Visit: www.childcarechoices.gov.uk for more information.

Funded Only Sessions

We have a very limited number of funded-only sessions available. These sessions are allocated termly and are offered strictly on a first come, first served basis. Please contact the Nursery Manager for details. Funded-only sessions do not include the cost of meals, snacks and any extras such as classes and trips. Funded-only sessions are offered as 2x extended AM or PM sessions (Universal/15-hours) or 5x AM or PM sessions for Extended Funding.

Tax-Free Childcare

Working parents are entitled to apply to join the Government's Tax-Free Childcare scheme, where you can claim up to £2000 per child, per year (£4000 for a child with a disability) towards your childcare costs. For every £8 you put into your Tax-Free Childcare account, the Government will top it up with £2. Please visit: www.childcarechoices.gov.uk to learn more.
